**Rate Information:** This Account is an interest bearing account. If the daily balance is more than \$599.99, but less than \$2,500.00, the interest rate paid on the entire balance in the account will be 0.25% with an annual percentage yield of 0.25%. If the daily balance is more than \$2,499.99 the interest rate paid on the entire balance in the account will be 0.30% with an annual percentage yield of 0.30%.

The interest rate and annual percentage yield may change. At our discretion, we may change the interest rate on the account At institution's discretion. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded monthly and will be credited to the account monthly. If the account is closed before interest is credited, you will not receive the accrued interest. Account Fees: Monthly service charge: \$8.00 + tax, if balance falls below \$600.00 per statement cycle. Transaction fee: \$.20 + tax will be charged for each check in excess of 20 if balance falls below \$600.00 during a statement cycle. The following fees apply to this account: Stop Payment: \$20.00; Returned Deposit Item Fee: \$5.00 per item; Closed Account within 30 days: \$10.00; and NSF Fee - Overdraft Charge, Return Item Charge: \$24.00 per presentment, (this may result in multiple fees assessed in connection with a single transaction when a merchant submits the same transaction multiple times for payment).
